BACKGROUND:

- * The Client is of the opinion that the Contractor has the necessary qualifications, experience and abilities to provide services to the Client.
- * The Contractor is agreeable to providing such services to the Client on the terms and conditions set out in this Agreement.

Services Provided

- * The Client hereby agrees to engage the Contractor to provide the Client with services (the "Services" consisting of: One on One Tutoring, Preschool Instruction, Computer Lab/Homeschool Assistance, the Services will also include any other tasks which the Parties may agree on. The Contractor hereby agrees to provide such Services to the Client.
- * The term of the Agreement (the "Term") will begin on the date of this Agreement and will remain in full force and effect until the completion of the Services, subject to earlier termination as provided in this Agreement. The Term of this Agreement may be extended with the written consent of the Parties.
- * In the event that the Client wishes to terminate this Agreement, there are NO refunds for prepaid services, including tutoring, classroom tuition, sunrise/sunset.

Payment

- * Except as otherwise provided in the Agreement, all monetary amounts referred to in this Agreement are in USD (US Dollars).
- * **Payment for all services are due at the time of service.**
- * Prepayment or payment at the time of service is required for Tutoring and Computer Lab scheduled sessions.
- * No Show/Missed sessions will result in a \$50 service fee.

Compensation

- * \$700 month School Tuition (preschool-12th Grade)... _____
- * \$50 per session for Private One on One Tutoring... _____
- * \$40 per session/day for Independent Computer Lab/Homeschool... _____
- * \$15 Sunrise per session... _____ \$30 Sunset per session... _____

Penalties for Late Payment

- * \$50 for NSF check or credit card payment
- * 10% late fee will be applied on the 6th to any unpaid balance from the invoice from the previous month.

Confidentiality

* Confidential information (the "Confidential Information") refers to any data or information relating to the Client, whether business or personal, which would reasonably be considered to be private or proprietary to the Client and that is not generally known and where the release of that Confidential Information could reasonably be expected to cause harm to the Client.

* The Contractor agrees that they will not disclose, divulge, reveal, report or use, for any purpose, any Confidential Information which the Contractor has obtained, except as authorized by the Client or as required by law. The obligations of confidentiality will apply during the term of this Agreement and will survive indefinitely upon termination of this Agreement.

* All written and oral information and material disclosed or provided by the Client to the Contractor under this Agreement is Confidential Information regardless of whether it was provided before or after the date of this Agreement or how it was provided to the Contractor.

Ownership of Intellectual Property

* All intellectual property and related material (the "Intellectual Property") that is developed or produced under this Agreement, will be the sole property of the Client. The use of the Intellectual Property by the Client will not be restricted in any manner.

* The Contractor may not use the Intellectual Property for any purpose other than that contracted for in this Agreement except with the written consent of the Client. The Contractor will be responsible for any and all damages resulting from the unauthorized use of the Intellectual Property.

Return of Property

* Upon the expiration or termination of this Agreement, the Contractor will return to the Client any property, documentation, records, or Confidential Information which is the property of the Client.

* Upon the expiration or termination of this Agreement, the Client will return to the Contractor any property, documentation, records, or Confidential Information which is the property of the Contractor.

Dispute Resolution

* In the event a dispute arises out of or in connection with this Agreement, the Parties will attempt to resolve the dispute through friendly consultation.

* Teresa's Little School reserves the right to discontinue enrollment of a student due to behavior, inappropriate conduct, excessive absences/missed sessions, destruction of property, lack of support from guardian(s), or delinquent account.

* If the dispute is not resolved within a reasonable period, then any or all outstanding issues may be submitted to mediation in accordance with any statutory rules of mediation. If mediation is unavailable or is not successful in resolving the entire dispute, any outstanding issues will be submitted to final and binding arbitration in accordance with the laws of the State of Washington. The arbitrator's award will be final, and judgment may be entered upon it by any court having jurisdiction within the State of Washington.

Modification of Agreement

* Any amendment or modification of this Agreement or additional obligation assumed by either Party in connection with this Agreement will only be binding if evidenced in writing signed by each Party or an authorized representative of each Party.
